What is the overall <u>deductible</u> ?	\$500 individual/\$1,500 family <u>network</u> .	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	<u>Network deductible</u> does not apply to office visits, <u>preventive care services</u> , advanced imaging tests, <u>emergency</u> <u>room care</u> , <u>emergency medical</u> <u>transportation</u> , <u>urgent care</u> , <u>rehabilitation</u> <u>services</u> , and prescription drug benefits. <u>Copayments</u> and <u>coinsurance</u> amounts don't count toward the <u>network</u> <u>deductible</u> .
